

# Qualifier Monday 20<sup>th</sup> June 2022 Golf Bluegreen Rennes Saint-Jacques

### Close of entries: Wednesday 15<sup>th</sup> June 2022

The qualifier is opened to all the players not exempt under the 2022 Challenge Tour Exemption Category Lists.

### 1. Qualifier

The competition will be played according to the Rules of Golf of the R&A Rules Limited, the 2022 Local Rules and Conditions of the Competition of the Challenge Tour and the Local Rules of Golf Blue Green Rennes Saint-Jacques.

- A. The tournament is open to a maximum of 100 players and entries will be accepted in the order of arrival.
- B. The tournament will be played over 18 holes stroke play formula. All the players will be playing one round on the course referred to in 1/C.
- C. The tournament will take place on Monday 20<sup>th</sup> June 2022 on the course Golf Bluegreen Rennes Saint-Jacques (Le Temple du Cerisier 35136 St Jacques de la Lande).
- D. The top 2 players, after playing 18 holes, will qualify to enter the Blot Open de Bretagne 2022.

### NB: Note for the Amateur players

The European Challenge Tour regulations forbid the participation of more than 6 amateurs in a Challenge Tour tournament that counts towards the "Challenge Tour rankings". The tournament committee has therefore decided to limit the number of amateurs qualifying from the qualifier to a maximum of one (1).

Only the leading amateur will qualify for the Blot Open de Bretagne <u>provided he ranks among</u> <u>the qualifier Top 2 players</u>. In case of a tie for this only spot, the qualifying amateur and alternates will be decided over a hole-by-hole play-off, immediately after conclusion of play

- E. In the case of a tie or ties for the final qualifying spots, these and the ranking of alternates will be decided over a hole-by-hole play-off, immediately after conclusion of play. The hole-by-hole play-off will be played over holes 10, 18, 10, 18 and so on until the 2 qualifying spot and the first 2 reserves are decided.
- F. If it was not possible to complete 18 holes on the day, the qualifier may continue the day after in case of exceptional circumstances.
- G. If one of the qualified players withdraws, he may be replaced by the first reserve on the qualification ranking up until Tuesday, June 21<sup>st</sup>, 12.00 hours. After this date, the place will return to the first reserve on the list of the Categories of French Tour Exemption Category List 2022.
- H. The Committee reserves the right to change or amend the above format, conditions, and schedule of play.



## 2- Entries

A. Eligibility:

Every professional from a recognized PGA.

Every male amateur with a maximum handicap of 2 or an index of 2,4 on the system of handicapping of the Federation.

B. Entry fee:

The entry fee is  $50 \in$  for the amateur players and for the professional players and  $40 \in$  for the teaching professionals from Blue Green group.

The payment will have to be made:

- For players living in France: Check payable to the Blue Green S.A

- Players living outside France: Bank Transfer (see account number below)

### This entry fee covers the entry fee to the Blot Open de Bretagne for the qualified players.

- C. Entry forms are available on the <u>https://rennes-saint-jacques.bluegreen.com/fr</u> website.
- D. To enter, players have to send, the registration form duly filled and their payment to: <u>By mail:</u> Golf Bluegreen Rennes Saint-Jacques Le Temple du Cerisier 35136 St Jacques de la Lande
- E. Entries for the qualifier will be open from May 28<sup>th</sup> and will close on June 15<sup>th</sup> (as attested on the postmark date).
- F. Responsibility of the player: the player must make sure that his registration has reached the Golf Bluegreen Rennes Saint-Jacques before the closing date of entries.
- G. An acknowledgement of receipt will be sent by e-mail to every player upon receipt of the complete entry form. The players will be considered as entered when they will have received this confirmation by e-mail. The entry list will be available on: http://frt.ocs-sport.com/tic/tmtic.cgi
- H. If a player withdraws before the closing date, his entry fee will be entirely refunded upon a written request sent to Golf Bluegreen Rennes Saint-Jacques. A player who withdraws after the closing date will not have his entry fee refunded under any circumstances.
  NB : Any player qualifying for the Blot Open de Bretagne Golf Blue Green Pléneuf Val-André under the 2022 Exemption Category Lists of Challenge Tour before tee off will be refunded. No qualified player will be refunded.
- All the entries will be subject to the Committee's approval which reserves the right to accept them or to refuse them or, having accepted them, to refuse them without giving the reasons of its decision. Conduct unbecoming a professional or non-competitive performance in a previous tournament, qualifier or Qualifying School can be a basis for the rejection of the application to enter by the Committee.
- J. The Committee can ask any player to demonstrate, in an independent way, his level of performance. For the amateurs, the licence number will have to be written on the entry form. For the professionals, a PGA card can be requested.
- K. The Committee can disqualify any player providing false information on his entry form.

# 3- Registration

All the players have to register before 12:00 the day before the qualification (on Sunday 19<sup>th</sup> June), It can be done by emailing to <u>jg.cirier@ffgolf.org</u> or <u>by phoning from Saturday 18<sup>th</sup> June to +336 60 83</u> <u>70 30</u>. The player is responsible for ensuring that his registration by email has been received.



# 4- Tee Times

Tee times will be available to the tournament office at the Golf Bluegreen Rennes Saint-Jacques or on <u>http://frt.ocs-sport.com/tic/tmtic.cgi</u> on Sunday 19<sup>th</sup> June from 15:00.

### 5- Practice round

All Professionals will be allowed to play a practice round, free of charge, on Sunday 19<sup>th</sup> June but will have to book a tee time in advance by calling the Golf Club on:

### 6- Measuring distance device

According to the Rule 4.3a, distance-measuring devices will be allowed during the qualifier.
